I agree the project description does not do a good job of describing the work within Prairie City that is being added.

The project description is set early on in our process, and is a general description of the area of the project. The project description is used in the State Transportation Improvement Plan (5-year plan) and connects all our documents for a project back to that. We have to use the same description throughout the development and construction of the project for that reason, although in this case, it doesn't describe the location of the work in the agreement. We need to keep the agreement project description as is, and have the attachment to the agreement accurately reflect the location of the work being agreed to.
