Prairie City Part-Time EMS Volunteer Director Staff Position

The City of Prairie City is seeking to hire a Part-Time EMS Volunteer Director. Hours will vary greatly and will be dependent on EMS calls for service, evening meetings and as needed for administrative duties. This is a volunteer position, but the Director will be paid at a rate of \$40.00/per call for service when they serve as the acting EMT for the Call.

Qualifications for this position are:

- Paramedic or EMT with minimum 5 years' experience
- Strong managerial, communication, interpersonal and leadership skills
- Management experience is preferred
- NIMS Incident Command Certifications preferred
- Additional credit given for any other Certifications, such as: CPR Instructor, Critical Care
 Paramedic, ACLS, PHTLS, PALS, NRP, EMS or Fire Instructor, Combat Life Saver

Applicants must be 18 years of age. Must have a valid Iowa driver's license. Post offer physical and drug and background screens required.

Primary job duties are, but not limited to: the enforcement of all of the Departmental and City and State laws, rules, regulations and by-laws, will preside at all regular special meetings of the EMS Department, and will serve as a medical care provider for calls for service while scheduled with additional duties as assigned.
