

Emily, thanks for circling back! This fell off my radar! My apologies!

Rates would be as follows:

Delivery \$100 Removal \$100 On call service \$65 So, if you left it all summer it would be \$100 delivery, plus \$65 X 4 services, plus \$100 removal = \$460.00. Note that the City would need to secure the dumpster outside these events to prevent illegal dumping, or otherwise pay additional service charges of \$65 if it needed emptied outside these events.

If you had it delivered and removed every time, it would be \$100 delivery, plus \$65 service, plus \$100 removal, X 4 events, = \$265/event X 4 = \$1,060.00.

2022 EMC Insurance Renewal

On the following page is the four-year comparison of the City's EMC insurance premiums by line of insurance. The premium is up this year largely due to the extreme weather that we have seen over the past two years, resulting in unprecedented claims. Many homes and farmsteads in the area surrounding Prairie City were affected by the December 15, 2021 tornadoes to the east and the most recent round of tornadoes March 5, 2022, to the west and north of town.

Because of this, it is imperative that the Commercial Property coverage for the City stays up-todate so that insurance coverage will be adequate to rebuild in the event of a loss. Keeping up with the rapidly increasing cost of building materials and the cost of contractors is key.

For the Commercial Property line of coverage, EMC provides blanket property coverage, which means that the entire blanket amount of coverage can be used to replace any building, contents belonging to the City, or structure in the open that has a coverable loss. The total amount of Commercial Property covered by the City's policy increased from 2021's - \$10,443,056 to this year's - \$12,525,005.

Also attached is the Statement of Values for City owned property showing how the \$12,525,005 is divided among the City's property.

The other lines of insurance are up slightly, but not outlandishly. The Linebacker and Law Enforcement premium increases are state-wide and reflect the current, quite litigious times that we live in.

On a bright note, the City of Prairie City has largely avoided claims of all types, not just dodged the weather, but also most every other type of claim has been non-existent in the recent past. This is helping immeasurably to keep rates as low as possible for the City during these times.
